

APPENDIX

Below is a list of all non-major Obama Administration energy and environmental rules enacted since June 13th, 2016 and published in the Government Accountability Office index. While the CRA defines a “rule” with the same meaning given to the term in § 551 of the Administrative Procedure Act, the CRA also includes three exceptions, of which a few may apply to this Appendix.¹ However, for the sake of completeness, all rules promulgated since June 13th have been included.
